If you make a deposit or full payment on a tour with *XTC Tours* you hereby agree to accept the terms and conditions of this contract.

**ITINERARY AND RATES** subject to change without notice. Price is that which is in effect as of 12/18/2019.

**RESERVATIONS REQUIRE** a per person payment of \$150.00 to confirm the reservation no less than 30 days before departure. Reservations made within 30 days, if space is available, require full payment and may be non-refundable.

**CANCELLATIONS** must be received in writing. Cancellations received 30 days or less before departure are not refundable unless the opening can be filled. All cancellations are subject to a \$50.00 per person handling fee. There is no refund for any unused services. *XTC Tours* reserves the right to cancel the tour any time prior to departure and is only liable to refund all monies paid by passengers.

**NOT INCLUDED:** Any items of a personal nature such as laundry, telephone bills, lift tickets, meals, ski rental, etc., unless it is stated as included on the front of the flier.
